

Residency Requirement: WI Driver License or State ID with current address: *only* a duplicate Drivers License with the new resident address is acceptable. Not an address change with the DMV.

Apply for a duplicate driver license online with WI DOT

To use this online application you must already have a valid Wisconsin driver license.

Your request for a duplicate license is NOT complete until you receive a confirmation message at the end of the transaction.

Please review everything below before using this online system.

Note: Once the online transaction is completed you cannot cancel the transaction, nor receive a refund.

Requirements

You will need the following items:

- Your Wisconsin driver license number, the last four digits of your Social Security Number (or your full Social Security Number if you don't have your Wisconsin driver license number available), your date of birth and your zip code.
- A valid Visa, MasterCard, Discover or American Express credit or debit card. Your credit or debit card will be charged a \$0.50 handling fee for this service in addition to the required duplicate [product fee](#). (*\$14.50*)

You will not be able to use this online system if:

- Your driver license is expired or will expire in less than 30 days. If you would like to [renew](#) your driver license please visit a [DMV service center](#)
- You are temporarily [out-of-state](#), your mailing address is outside of Wisconsin or you have a special mailing address. A driver license applied for online will be mailed to your Wisconsin residence address and cannot be forwarded to any other address.
- Your driver license is suspended, revoked or cancelled.
- You need a duplicate commercial driver license or motorcycle instruction permit.
- You are not a U.S. citizen.
- You are under the age of 18.
- You are 18 - 25 years old and previously ordered a duplicate driver license online.
- You are over the age of 25 and have ordered a duplicate driver license online within the past two years.
- You wish to change an eyeglass or contact lens restriction.
- You have had a legal name change since your driver license was last issued.
- Your photo is not on file at Wisconsin DMV.
- You would like to apply for an original (first time) REAL ID-compliant driver license. Persons applying for a REAL ID-compliant driver license for the first time must visit a [DMV customer service center](#).

Driving receipt

A driver license receipt, including your photo, will be available for you to view and print upon successful completion of this online transaction. This receipt is acceptable photo identification for voting and serves as your ID until your card arrives in the mail. Adobe Reader 6.0 or higher is required to view and print driver license receipts.
